

## **PRIVACY POLICY STEPHANE BVBA**

### **1. SCOPE**

Stephane BVBA cares about your privacy, and in this regard always acts in accordance with the provisions of the Belgian Privacy Law (*Law of 8 December 1992 on the protection of privacy in relation to the processing of personal data*). Read this Privacy Policy to find out more about the way personal data are collected and processed on its websites.

This Privacy Policy is applicable to the websites operated by Stephane BVBA (hereafter referred to as a "Website"). The registered head offices of Stephane BVBA are located at Generaal Lemanstraat 4, 2600 Antwerp, Belgium, and its company number is 0884.709.878.

By using the Website and communicating personal data, you formally agree with the conditions indicated below under which Stephane BVBA collects, processes and transfers and/or (depending on the case) you guarantee that these conditions have been communicated to and accepted by the individuals concerned to whom the personal data relates.

### **2. SECURITY**

Stephane BVBA undertakes to take all suitable technical and organizational measures to protect your personal data against destruction, loss, unintentional modification, damage or disclosure.

### **3. PROCESSING OF PERSONAL DATA**

#### **3.1. Collection, processing and purposes of the personal data on the Website**

For each use of the Website, different personal data and log files about you are collected, i.e. your IP address, the website from which you are redirected to the Website, the date and duration of your use of the Website, your browser, your operating system, your surfing behaviour and, more particularly, the pages you visit on the Website.

These data are only used for statistical purposes and to analyse and optimize the functioning and the use of the Website. To this end, Stephane BVBA uses the tracking software services of third parties to which these data are communicated for these purposes. The use of such software does not allow Stephane BVBA to identify the user of the Website.

As from the moment that your visit is not limited to general information gathering and, more specifically, when, using the Website, you (i) register or log into your account, and use features available only to logged-in users; (ii) contact Stephane BVBA; or (iii) agree to receive the newsletter of Stephane BVBA, additional data are moreover requested and/or collected, including your name, email address, password and, if applicable, language preference, telephone number, address and payment details.

Such data are used respectively:

(i) to let you use your account on the Website, including by saving your data and profile data, to optimise, improve and maintain the Website, to enable you to purchase a paying subscription on the Website as well as for purposes of customized marketing via emails and to customise the Website according to your preferences;

(ii) to deal with your question, request or communication and to answer if applicable; and

(iii) to provide you with the newsletters and customized marketing via email, when you sign up for them.

and, to this end, can be transferred to third parties as explained below.

### **3.2. Transfer to third parties**

Stephane BVBA may also transfer certain personal data to third parties, among other things, for the following purposes:

- To service providers of Stephane BVBA insofar needed for the maintenance, management and performance of the Website;
- To the competent authorities in case of threatening or pending legal proceedings.

These third parties act as a "data controller" during the performance of these and other processing of personal data. For more information regarding these processing, Stephane BVBA therefore also refers to the applicable privacy policy of these third parties.

### **3.3. International transfer**

By using the Website, you expressly acknowledge and agree that, in the framework of the mentioned processing of personal data, data can be transferred to countries outside the European Economic Area, not affording a similar level of protection for personal data.

### **3.4. Location data available on the Website**

Using the functionalities of the Website, maritime location data including the type of vessel, position, course and speed is displayed. Such information is not stored or processed for longer than 72 hours. Stephane BVBA adheres to applicable Belgian Privacy Law when displaying such information.

The Website will not collect your location data when consulting the maritime location data provided on the Website. Any information you input or upload will only be processed in accordance with the applicable General Terms and Conditions.

## **4. RIGHT OF ACCESS, ADAPTATION AND RECTIFICATION**

As provided for by Belgian Privacy Law, you have a right of access, adaption and rectification of your personal data, at any time and free of charge. If you have an account on the Website, you have the possibility to manage and modify your profile data yourself and to

choose to stop receiving emails from Stephane BVBA. Similarly, you can oppose, free of charge, to the processing of your personal data for direct marketing purposes in contacting, in writing, the Stephane BVBA, at the address indicated below.

## **5. COOKIE POLICY**

This section of the Privacy Policy contains Stephane BVBA's cookie policy and explains which cookies are being used on the Website. Stephane BVBA uses cookies within the framework of its general policy regarding the protection of your privacy and the processing of your personal data.

### **What Are Cookies?**

Cookies are small information files which are saved by the server of a website through the browser temporarily or permanently on your computer or device. Cookies contain a unique code, which enables to recognize your browser during your visit to a website (this is a "session" cookie") or also during later visits (this is a "permanent" cookie). Cookies enable to simplify, complete or personalize the use of a Website.

### **Use of Cookies on the Websites of Stephane BVBA**

The Websites of Stephane BVBA use different types of cookies:

#### *Necessary cookies*

These cookies are indispensable to be able to visit the Websites and to use certain areas. These cookies allow you for example to navigate between website areas, or to fill out forms. Cookies are necessary when you wish to log in to the Website client area in order to securely verify your identity, before we grant you access to your personal information. If you decline to use these cookies, certain areas of the website will not function or not function properly.

#### *Functional cookies*

Functional cookies are cookies that facilitate and make the use of the Websites more pleasant and enable a more personalized surfing experience. These are cookies that for instance remember your language preferences, and the cookie which keeps track of whether you were already asked to participate in a survey, as to not present you time and again with the same survey.

#### *Performance cookies*

These are cookies that serve to gather information on the way in which visitors use the Websites, such as information regarding the number of pages visited or the number of error messages displayed, to analyse and optimize the use of the Websites.

### **Management of cookies**
